Emissions reduction targets

[Instructions to Suppliers:]

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 10 tCO₂e by 2028. This is a reduction of **10%**. This percentage takes into account that AltaRange Ltd is expecting to expand rapidly both in output and personnel numbers in the next 5 years.

Carbon Reduction Projects

Project 1: Decreasing travel of employees by employing more local employees and promoting homeworking

Project 2: Engage with the landlord to encourage use of green energy suppliers and renewable energies in the future.

Project 3: Work with our suppliers to increase the amount of recycled material used in the products we purchase from them. Moving to suppliers with higher use of recycled material.
